

The testimony of the car crash I had, which I believe was in 1979

The basic dates, the crash was in the summer of 1979, I was saved 23 years later on 24th Nov 2002, Then in 2004 approx 25 years after the crash, God revealed to Angela all the details of that night, plus ***one thing I didn't know until she told me.***

The Story; I was road racing as we did in those days, we had come through St Peters Valley going up towards St Mary, I took the left fork in the road before Granite products which takes you up to St Peter, at the top of this road there was a bad cross junction, a known black spot, but I wasn't aware of that, I recall doing 90mph along this section before I drove straight through the junction where I was hit in the side by another car, this poor man was driving home from a late shift at the airport, both our cars were destroyed in the crash, weeks later I was taken to the Parish police compound to see my car so I could see what I escaped, I was told the steering column was broken in 5 places and I could see it had penetrated the driver's seat, I had been thrown out of the car on impact as I had no seat belt, I realised this saved my life.

No one was killed which was really a miracle, I don't know how the other man escaped, but my passenger and I were thrown out the passenger door, I landed on top of him breaking his collar bone, I was in and out of consciousness most of the time, then the emergency services arrived, Honary police first then the Paramedics, I only remember seeing these two. The Honary policeman was in a flap making radio calls and running up and down, I watched as I lay on the ground complaining of head and neck pain. Then the ambulance arrived and checked each one of us out, I remember them putting my head in a brace, the policeman asked the paramedic about me, I heard him say, I don't think he is going to make it, I can recall thinking that's not encouraging, then I was unconscious and later woke in hospital.

The testimony; I remember about two months later at a Parish Hall enquiry the centinier saying as he opened the enquiry, that he was delighted to be prosecuting me, because that night he didn't expect to ever be holding this enquiry, I replied I am delighted to be prosecuted as I remembered what the paramedic had said about me the night of the crash. 25 years later the Lord revealed to Angela the whole crash seen, she saw the grass bank I ended up on, she saw my car and even told me its colour, she saw a man running up and down and another standing still, she asked me to explain who these people were, they were the policeman and the paramedic, then she told me what I didn't know. ***She said there was another man, He was on the grass next to you, as you lay on the grass He knelt beside you with His hand just above you and He was praying, she said whilst others ran up and down He prayed very focused, she heard Him say the words " I will never leave you nor forsake you"*** This was the real miracle to me, that 23 years before I gave my Life to Jesus, He knelt next to me Himself and prayed over me, Angela said the Lord placed Himself between you and the paramedic who had spoken death over you, but Jesus reversed that report and said, "I will never leave you nor forsake you" How amazing is that, God was fighting for me 23 years before I was even aware of Him, what a Loving Father and mighty faithful God we serve....!
